**Prior to a breeding agreement we require the owner of the Dam/Bitch to provide us copies of the following items:**

1. A copy of the Dam/Bitch's pedigree
2. A copy of her AKC registration certificate
3. Copies of her OFA certifications, CERF certification, PRA DNA test results, and all other health testing done
4. A recent photograph, side view preferable, or a recent video of the Dam/Bitch

**It is our desire that your Dam/Bitch have the same or similar health evaluations and certifications. The following are the requirements that must be met prior to the breeding of said Stud Dog.**

- 1. The Dam/Bitch must be at least 22 months of age and less than 7 years of age at the time of this breeding.**
- 2. The Dam/Bitch must be proven to free of Hip and Elbow Dysplasia as evidenced by an OFA Certification or equivalent certification from the Dam/Bitch's country of origin.**
- 3. The Dam/Bitch must have a current CERF Report clear of PRA and other eye diseases and dated within (1) one year of this breeding or the Dam/Bitch must be proven free of PRA DNA Gene as evidenced by an Optigen DNA Certification on the Dam/Bitch or by copies of the Optigen DNA Certifications of both parent dogs of the Dam/Bitch.**
- 4. The Dam/Bitch must be an American Kennel Club, Canadian Kennel Club, and/or International Kennel Club registered Mastiff. No other canine kennel club is acceptable.**
- 5. The owners of the Dam/Bitch will not produce more than (8) eight litters in any (24) twenty-four month period.**
- 6. The Dam/Bitch must be in good health at the time of this breeding.**
- 7. The owner of the Dam/Bitch warrants that this Bitch has not been exposed to any stud dog prior to this breeding and will ensure and protect her from exposure to another stud dog after this breeding.**
- 8. The owner of the Dam/Bitch agrees to not knowingly sell, give, or transfer puppies whelped as a result of this breeding to any person or firm connected to or associated with the business of trade, resell, retail, wholesale or commercial breeding of dogs or for using dogs in laboratory testing or clinical research.**
- 9. The owner of the Dam/Bitch must agree to be responsible for the appropriate placement and/or sell of these puppies and must agree to sell or place each puppy with a written contract.**
- 10. All puppies whelped from this breeding must be registered with one of the following acceptable kennel clubs including The American Kennel Club, The Canadian Kennel Club, and /or The International Kennel Club. No other kennel club registration is acceptable.**
  
- 11. The owner will require health testing of these puppies, to help further the generations of mastiffs in the future.**

## **The Breeding Method:**

We only breed by Artificial Insemination. This assures us that our stud dog will not receive any sexually transmitted disease. This is for the protection of our stud dog and your bitch.

\_\_\_\_\_1. **Fresh Chilled Semen shipped via Federal Express.**

No deposit is required prior to collection. We guarantee the semen to be satisfactory upon veterinarian examination. All veterinary collection expenses, the fresh chilled semen kit, and all transportation expenses will be the responsibility of the owner of the Dam/Bitch. All charges will be paid directly to Animal Clinic Northview for collection procedure. The deposit is applied to the balance of the stud fee after the litter is whelped.

\_\_\_\_\_2. Frozen Semen

No deposit is required prior to collection. All charges connected with releasing, processing, and shipping said semen will be the responsibility of the owner of the Dam/Bitch. The charges will vary depending on which center is utilized. All charges will be paid directly to Animal Clinic Northview for collection procedure.

## **THE STUD FEE**

**The stud fee is (call for pricing). A deposit of \$500.00 is payable at the time of signing of this agreement, and the remainder of the fee is payable when the litter is (8) eight weeks of age.**

## **OTHER CONDITIONS**

Smokerise will sign the appropriate litter registration form when the pups are born and payment in full will be due upon the sale of first puppy.

One puppy born constitutes a litter.

If the litter delivered contains (3) three or less puppies, the stud fee is (\$600.00) six hundred dollars per puppy.

If the puppies are conceived, yet lost due to negligence in the whelping care of the Dam/Bitch and puppies. The balance of the stud fee is due.

If the Dam/Bitch fails to conceive, then no stud fee is charged. A return stud service will be provided without deposit provided the owner of the Dam/Bitch notifies Smokerise within (14) fourteen days after the projected whelping/delivery date that no puppies were conceived.

Smokerise will assist and provide pedigrees, photographs, and promotional material of **Windfalls Rolling Thunder** and we will aid in the placement of the puppies that result from this breeding to good homes if necessary.
